- 1. In consideration for participating in PERFORMING ARTS CLASSES, PERFORMANCE CAMP, RECREATION, ATHLETIC ACTIVITIES, FITNESS ACTIVITIES OR ANY OTHER ACTIVITIES DIRECTED BY CENTRE STAGE AT BALLET ARTS, LLC. aka BALLET ARTS - THE PERFORMING ARTS CENTER OF SOUTHERN WESTCHESTER (HERETOFORE CSBA-LLC) and other valuable consideration. I hereby RELEASE. WAIVE, DISCHARGE AND CONVENANT NOT TO SUE CSBA-LLC, their officers, servants, agents, and employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASES, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted or in transportation to and from said premises.

DRESS CODE FOR MASTER CLASSES

GIRLS – Black camisole leotard, ballet pink tights with convertible feet. Appropriate shoes for the individual dance classes. Girls hair neatly tied back in a ballet bun.

BOYS – Black shorts or black tights, a solid white T-Shirt and appropriate shoes for individual dance classes.

DRESS CODE FOR GROUP CLASSES

Girls' Ballet, Pre-School & Kindergarten & IA: Ballet pink, short-sleeved, tank or camisole leotard. Skirt attached or unattached is optional. Ballet pink tights ad ballet pink slippers. All hair pulled back in a ballet bun. No jewelry.

Girls' Ballet I, II, III, IV, V: Black short- sleeved, tank or camisole leotard. Skirt attached or unattached is optional. Ballet pink tights and slippers. All hair pulled back in a ballet bun. No iewelry.

Boys' Ballet, All Levels: White short-sleeved T-shirt, black shorts, and black ballet slippers.

Girls' Jazz & Tap: Black short-sleeved, tank or camisole leotard, black tights, and black jazz shoes/black tap shoes. All hair in a pony tail.

Boys' Jazz & Tap: Black shorts, black T-shirt, black jazz shoes or black tap shoes.

Hip-Hop: Black shorts with a solid color shirt and Hip-Hop shoes.

Adult Dance: Comfortable form fitted clothing. Jazz or ballet shoes, preferred.

Adult Tap: Shirt, shorts or leggings and tap shoes.

Lyrical: Black short sleeve, tank or camisole leotard, footundeez or lyrical shoes, ballet pink footless tights. All hair in a pony tail.

Tumbling/Acro: Form fitted shorts, leggings and shirt. Socks or barefoot. Girls hair pulled back in a ponytail.

- Registration or attendance in any of our programs constitutes a general release of your image or likeness.


